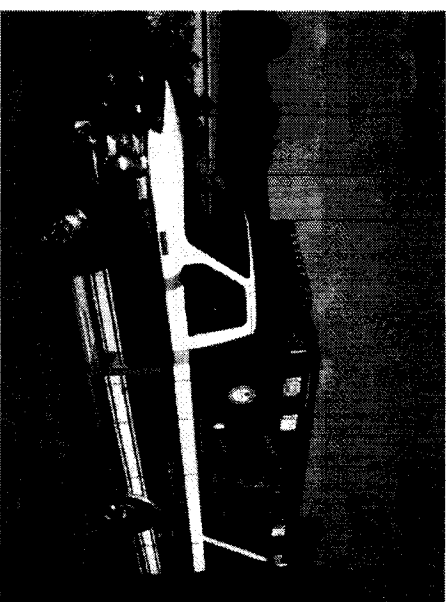

Why Become a Subscription Member?

Subscribing entitles you to Medically Necessary ambulance services, as often as needed, contingent on availability of equipment and personnel, for one year (June 1 to May 31). This service extends to Lehigh Valley Hospital Schuylkill and Geisinger Shamokin hospital. As a subscriber, Washington Fire Company Community Ambulance will bill your insurance company and accept as full reimbursement what your insurance company allows for the service (Copay and Deductibles may apply). **Subscribers who receive checks from their insurance company for services rendered by WFCCA must forward these checks to the Washington Fire Company Community Ambulance.**

If Not a Subscriber - What are the Costs?

As a community based organization Washington Fire Company Community Ambulance will provide Medically Necessary emergency services to all of our citizens. But a non-subscriber will be charged a basic fee per trip as well as all other fees not covered by insurance.

Washington Fire Company Community Ambulance is a Non-Profit community based volunteer organization whose mission is to provide the highest quality service and equipment to our citizens. Our goal is to be there for you and your family when you need us. (We do not depend on tax dollars to continue our work but depend on our subscription drive to provide the financial support to meet the needs of our community.)

Your subscription gives us the funding to cover our operating expenses:

- Fuel
- Insurance
- Equipment Maintenance and Updating
- Staffing/Professional Training

Take Note that the Washington Fire Company Community Ambulance subscription drive pertains to transport done by the WFCCA. The Washington Fire Company Community Ambulance is not responsible for bills received from another Ambulance Association that may be involved with the patient's treatment.
